The idea is to continue the work that was instigated with the Restoration Program (the ATE Pillar Project) and the attempt to repair the original lineages of our reality. Of course, reality has changed since then (and the mission as such failed) and lots have been done to our template under the forces having their projects here, but to be able to reconstruct our template, using whatever viable genetics we have got left, we need the to understand the original construction first, why it was made and what its purpose was. So, let us begin with Course 1.....





The DE1-LPRF1 Reality Fields – the Foundation of the Artificial Energy Systems – Now Resetting




The illustration shows how gridworks turn into networks. A gridwork is the central racial field of a LPRF holding the encoded energy units as well as the plan for that reality field as it was laid into the gridworks by the Progenitors. Only when the genetics link up to a gridwork are they able to progress.

The concentric domains as they unfold into our reality in density settings, where each domain covers several sub-fields, as explained in the HAL Books.

The Higher Order Transformative Energy System in the LPRF1-DE1-OD



The higher order energy system can be viewed as multilayered composition of several energy fields with different access points, energetic orientation and processes of consciousness and energy. It expands from the personal experiences into the reality fields of similar forms of energy fields and consciousness processes.

The higher order energy system is thus a composition of the processes of raw consciousness and energy units to be developed and already transformed consciousness units (the CUs) and energy units. The goal of these processes is to develop new forms of existence.

The Merged Lower Order Brain & Higher Order Radiation Processes

Transmuted Neuro-Electric Processes (biological and otherworldly) into expressing the functional CUs adapted to ego structure. Transmuted Neuro-Chemical Processes (biological and otherworldly) into expressing the lower and higher order knowledge. Transmuted Subtle Energy Processes (biological and otherworldly) into expressing the dual information systems. Transmuted Code Layer (lower order planetary and higher order otherworldly) into expressing the dual code layer systems.

The Merged Lower Order Emotional & Higher Order Vibration Processes

Transmuted Electro-Chemical Processes (biological and otherworldly) into incorporating timeline & reality field dynamics. Transmuted Nervous System Sensations (biological and otherworldly) into incorporating activation & amplification dynamics. Transmuted Subtle Energy Processes (biological and otherworldly) into expressing the dual information systems. Transmuted Code Layer (lower order planetary and higher order otherworldly) into expressing the dual code layer systems.

The Individual Challenges in the Work

The individual challenges involve the work with the lower order fields and how we can clear these to get to the point, where we can rebuild our higher order constitution. As long as we are trotting along in our human form, exercising our human will, mind and emotions, we will not get to the higher order levels in us. The higher order levels of us contain the consciousness genetics, the original template and higher order energy system. These parts have been hidden from us. We are to figure out how to reconnect to the true parts of us and then put in the needed work to activate them.

To get to where we can recreate all that we are, we must solve the puzzle of the in-the-way lower order fields, i.e., the electromagnetic controlled overlay of the bio-field and DNA, along with the emotional field and mental field that hold programming to fit us into the base program (aka the ISP). The lower order fields are inserted to block the higher order energy system from connecting to our organic bio-field and allow our own code systems to unfold, leading us back to the density energies we also are able to process and integrate.

The higher order energy systems and the organic vessel with its three lower fields:

Higher Order Energy System – the True Human; Progressive
Consciousness units
Code sheets, configuration and template
6D Energy system fitting the original solar system

Lower Order Fields – the False Human; Regressive

Mind-field to be altered into the 5th cycle brain field Emotional field to be altered into the 4th cycle heart field Bio-frequency field to be altered into the 4-5th cycle bio-density field

Organic form – Molecular

Bio-frequency matter is to be cleared and transformed by our activation of the higher order energy system, and then returned into density units, so far as it is possible, following the original DE1 OD settings.

What humans hold of inserted alien technology and their subsequent alien DNA (altered extra-terrestrial genetics altered into being able to latch on to the human DNA) will be shown in the bio-energetic clearing processes and get control of the unconscious electrochemical processes in organs, glands and cells. It will also be shown in the visions, or memories of past lives, defining the current emotional field and its content.

Therefore....

- 1) The main goal of this work is to clear the regressed LPRF2 and infected LPRF3 inserted genetics, technologies and distortion fields from the three lower energy fields...
- 2) To get there all groups must work with the psychic-energetic transformation processes of the three lower fields in the lower order energy system....clones hold these as well.
- 3) Everything is interconnected....from the reality field energies to the energies of our higher and lower energy systems, and into the smallest unit found in the cellular construction.
- 4) When one layer is worked with, the other intersecting energy fields are also worked with.

What are the Template Sciences?

- They are the sciences behind the construction of the template. This specific type of construction was developed in the Pillar Project to accommodate for a higher order energy system suitable for the developmental programs unfolded within the Pillar Project. The template is thus unique for our solar system.
- They cover the methodology to work with the template according to the developmental programs of the Pillar Project, and thus go hand in hand with the 6 Pillars of Knowledge.
- The Principles of Progression, the Rules of Engagement and the Energetic Laws are foundational for the construction of the template. Upholding these ensures a functional template, that is generates new energy units. If these were not followed, the template would eventually be removed from the Library due to the dynamics of segregation (as explained in *the HAL Philosophy book*).
- The state of the template determines the progression dynamics and ability to work with the chiasm and timelines via the high order developmental sciences.
- ATE, the template was reengineered to alter the effects of the timeline event, to clear the ATE genetics & timelines, and to determine the continuation of the races as either failed or as a success.


The Higher Order Information Systems as Developmental Processes

As we recall from the HAL Transition Science Material: In the work with the energetic-dynamic cycles of the concepts of spheres within spheres and probability fields we work with different dynamics that stem from outer and inner very subtle energetic influences. Via the energetic-dynamic work with the different spheres and fields, and their complex information systems, we expand our perception sphere of knowledge using these energetic dynamics. We recall the psychic-energetic sensing and higher order cognitive abilities as a 6-step ladder of perception dynamics to unravel the complex information system we are addressing:

- Linear psychic-energetic sensing and higher order cognitive dynamics investigating the item from the perception process of sequences of units (Step 1 of the perception dynamics).
- Processual psychic-energetic sensing and higher order cognitive dynamics investigating the item from the perception process of opposition dynamics (Step 2 of the perception dynamics).
- Systemic psychic-energetic sensing and higher order cognitive processes investigating the item from the perception process of synergetic dynamics (Step 3 of the perception dynamics).
- Information system psychic-energetic sensing and higher order cognitive processes investigating the item from the perception process of holographic dynamics (Step 4 of the perception dynamics).
- Coding and decoding psychic-energetic sensing and higher order cognitive processes investigating the item through perception processes of complex code information systems (Step 5 of the perception dynamics).
- Integrative psychic-energetic sensing and higher order cognitive processes investigating the item via replication dynamics (Step 6 of the perception dynamics).


The Natural Laws administer the accurate use of the diverse forms of energy a world is composed of. This includes the Rules of Engagement to ensure the appropriate energetic exchange in all interaction in any interracial behavior, since every and all interactions are an exchange of information, energy and consciousness and thus a utilization of reality energy or human energy. How to do this in the accurate ways were merged into all progressive developmental programs.

The different universal lineages and the pillars are positioned in the domains on density 1-5, within 12 dimensions in a ring set up, i.e. *the rings of progression*.



The pillars unfold within each domain, where different aspects of the template, energy system and organic vessel are developed. All within the respective reality fields, using the dimensional energies. Density 5 and dimensions 13-15 are not for all.

The Original Pillar Project Developmental Programs


In the old progression worlds, there were no teachers of progression, since every human could - at all times - connect to the holographic teaching systems (the HTS) and there get the results of any choice to be made according to the Principles, the Rules and the Laws of that system, i.e., how the reality energies would work on the template in that type of density and reality, if we made that choice.

The HTS were interactive and simulated possible scenarios according to the template, we had constructed and what we had decided to achieve in the system, we were part of. Furthermore, the HTS interacted with the chiasm, showing possible outcomes on all holographic levels of the reality field.

If the possible futures were not suitable for our continued progression, we would change our ways or recode our code sequences to fit the system, we were part of in a better way. We utilized our consciousness to do so, since we were the ones that had engineered our template and energy system, when we entered that system. Thus, if our template did not work, it was our responsibility to fix it.

Consequently, we are the only ones knowing how our template works and how it is engineered in detail. This is important to understand, because the underlying coding in everything we are, is something we have engineered. We learned that in the first two pillars. We are sovereign in all that we are and we do not need teachers to make us become whole again. But we need other lifeforms and surroundings to mirror to us what we are, so we can self-correct and self-adjust. And, as things are now, humans that resonate with us on the same level of work.
